

EXECUTIVE SUMMARY

The 2022 Annual Report is an overview of the various activities and growth of the PTCC during the January 1 to December 31 time frame. Accomplishments include:


- Assisting two member states in completing the implementation phase, thereby enabling the active issuance and acceptance of compact privileges (CPs) 2022
- Issuing a record-high of more than 5,700 CPs to physical therapists and physical therapy assistants
- Working with member states to address barriers to compliance
- Developing educational materials for "pre-Compact" legislators, state associations, and Boards, as well as compliance and implementation resources for member jurisdictions
- Increasing outreach efforts via the Simplify campaign
- Completing the 2024-2027 PT Compact strategic plan
- Reviewing and amending governance documents
- Achieving a positive operational net income since its formation

LEGISLATIVE ACTIVITY

No additional jurisdictions enacted PT Compact legislation in 2022. There continued to be thirty-four total member jurisdictions at the end of the year.



IMPLEMENTATION

After enacting the model Physical Therapy Compact legislation, a jurisdiction must work to implement all the requirements of the PT Compact before being ready to actively issue and accept CPs. The responsibility falls upon the licensing board, and the amount of time, work, and difficulty to implement the requirements can vary widely.

In 2022, two states completed implementation and began issuing and accepting CPs. These states were Wisconsin and South Dakota, both of which enacted PT Compact legislation in early 2020 but ran into roadblocks that were finally

resolved in late 2022. The primary barrier in both states was related to the need to upgrade technology to either enable data sharing or allow compact privilege purchasers to take the jurisprudence exam. These two additional states brought the total number of active Compact jurisdictions to twenty-seven.


Several implementation barriers in 2021 persisted throughout 2022, which hampered progress in the remaining seven member jurisdictions (Alabama, District of Columbia, Indiana, Kansas, New Jersey, Pennsylvania, and South Carolina). The implementation roadblocks fall into three main categories: (1) getting FBI approval for the criminal background check requirement; (2) getting approval as well as technological support to allow for weekly sharing of licensure data with the PTCC; and (3) the adoption of rules and regulations to implement the Compact. Because of these issues, the implementation process continues to average between eight and twelve months after legislation enactment.

The PTCC continues to reflect on lessons learned from previous years to assist newer compact states in reducing their implementation time frames.

COMPLIANCE ACTIVITIES

The PTCC Compliance Committee continued the work started in 2021 to ensure compact member state adherence to PTCC rules, policies, and requirements. In addition to continuing regular audits of CP holder eligibility, the committee met multiple times to review member state compliance in several key areas, including weekly submission of licensee data, timely entry of disciplinary actions, flagging of encumbrances and investigations, and the storing and sharing of the FSBPT ID in a weekly data file. These compliance reports are also sent to member jurisdictions. If a compliance issue is identified, the Compliance Committee meets with the member state board to clarify the barriers as well as provide training and remediation. As seen in Figure 1, throughout 2022, quarterly compliance in all active compact jurisdictions remained above sixty-five percent in each of the four key areas. For all active compact jurisdictions, weekly submission of licensee data and timely entry of disciplinary actions had consistently high compliance rates at eighty percent or more throughout the year. The use of the FSBPT ID was the

biggest area of noncompliance, however did show steady improvement from January to December. Notably, active jurisdictions struggled the most with consistently flagging investigations within fourteen business days of the effective date of an adverse action against a licensee or compact privilege holder.



In May 2022, the PTCC Compliance Committee held a joint meeting with the Federation of State Boards of Physical Therapy (FSBPT) Examination, Licensure, and Disciplinary Database (ELDD) Task Force. FSBPT staff highlighted improvements in state participation in the ELDD over the last few years. To further encourage and maintain ELDD participation, FSBPT set aside a 2.2 million dollar grant for PT Compact member jurisdictions to submit data to the ELDD, including the key compact compliance areas. By the end of the year, Indiana, lowa, North Carolina, North Dakota, Ohio, Oregon, and Texas all successfully submitted grant proposals and were awarded funds to support consulting, programming, data entry, technological upgrades, and other activities that

enhance updates to the ELDD. For instance, in Iowa, North Carolina, Ohio, and Texas, instead of a weekly data file being sent to the ELDD, the implementation of an Application Programming Interface (API) now allows for daily updates. In Iowa, databases were also modified to track a licensee's FSBPT ID as the unique identifier instead of the individual's social security number. Such enhancements are soon anticipated to

improve compact member compliance in the key areas mentioned.

COMPACT PRIVILEGE ISSUANCE

The PTCC had record growth in sales throughout 2022. A total of 5,720 compact privileges were purchased in 2022. Of this total, 4,412 were initial purchases and 1,308 were for the renewal of an existing CP. As of December 31, 2022, there were 5,284 active CPs held by 4,157 unique CP holders.


Consistent with the upward trend in the practice of telehealth which expanded during the pandemic, a majority of CP purchases came from licensees seeking to provide physical therapy in multiple compact states via a digital platform.

COMPACT PRIVILEGES 2022 VS 2021




Practitioners employed by companies with facilities in multiple jurisdictions were the next biggest group purchasing CPs. Finally, the third most common reason for the purchase of CPs came from licensees with travel therapy assignments in multiple compact states.

At the end of 2022, CPs were being issued in twenty-seven compact jurisdictions. Similar to 2021, Washington, Virginia, and Texas led the way in the greatest number of CPs issued at 571, 465, and 400, respectively (Figure 2). Eighty-five percent of the active member states issued more than 100 CPs in 2022, which is a significant increase from 2021, during which only sixty-four percent of the active member states issued more than 100 privileges.



Monthly CP purchases in 2022 have increased compared to the last four years, with a record high in December (Figure 3). Consistent with previous years, most CP purchases are for the initial issuance of the privilege. In 2022, seventy-seven percent of all purchases were for initial issuance and twenty-three percent were for renewals, whereas in 2021, only sixteen percent of the purchases were for renewals. The amount of CP renewals has steadily increased since its inception (Figure 4).







Appendix A

2022 PT Compact Rules Amendments Adopted by the Commission on October 30, 2022

2022 Draft Amendments to PT Compact Commission Rules Recommended by the Executive Board

Please note that additions are indicated by <u>red underlined</u> text. Deletions are indicated by <u>red strikethrough</u> text. Black text is existing unchanged text.

1) Rule 7.1(I) – Adoption of Rules; Amendments

Reason: To conform the existing rule with the model compact statute.

Proposed Amendment:

- (I) Upon determination by the Executive Board or Commission that an emergency exists, the Commission may promulgate an emergency rule that shall become effective immediately upon adoption, provided that the usual rulemaking procedures provided in the compact and in this section shall be retroactively applied to the rule, no later than ninety (90) days after the effective date of the rule. An emergency rule is one that must be made effective immediately in order to:
 - (1) Meet an imminent threat to public health, safety, or welfare;
 - (2) Prevent a loss of <u>Commission</u>, federal, or <u>member</u> state funds;
 - (3) Meet a deadline for the promulgation of an administrative rule that is established by federal law or rule:
- 2) Rule 6.4 Frequency of Reporting Adverse Actions and Non-Disciplinary Encumbrances Reason: To change the timeframe for reporting disciplinary actions to the Compact Commission.

Proposed Amendment:

- (A) Within two (2) business days of the effective date of the adverse action against a licensee or compact privilege holder, the Licensing Board shall, through the interface described in rule 6.3, at a minimum, report the following information and complete the following action:
- (1) Home Address.
- (2) Date Action Became Effective.
- (3) Select a Save Status of Temporary.
- (B) (A) Within fourteen business days of the effective date of the adverse action against a licensee or compact privilege holder, the Licensing Board shall, through the interface described in rule 6.3, complete all required information and select the Save Status.
- (C) (B) Within two (2) fourteen (14) business days of the effective date to void, update, revise, or correct an adverse action against a licensee or compact privilege holder, the Licensing Board shall report such decision to the Commission through the interface described in rule 6.3.
- (D) (C) Within two (2) fourteen (14) business days of the effective date to impose a non-disciplinary encumbrance on a license or licensee or on a compact privilege or compact privilege holder, the Licensing Board shall report such decision to the Commission through the interface described in rule 6.3.
- 3) Rule 3.5 Expiration or Termination of a Compact Privilege Reason: To clarify the change of home state notification requirements.

Proposed Amendment:

(A) All compact privileges shall expire on the actual expiration date of the home state license even if the home state allows practice beyond the license expiration date.

As Recommended by the Executive Board on 9-6-2022

- (B) Impact of changing the primary state of residence.
- (1) Moving to another member state.

- a. The compact privilege holder must hold an active license in the new home state prior to changing the primary state of residence or all current compact privileges will be terminated. Thirty (30) business days after the date of legal change of permanent address is considered the date of change in home state.
- b. When a compact privilege holder obtains the license in the new home state and changes the primary state of residence, the expiration date of all current compact privileges will be updated to match the expiration date of the new home state license.
- (2) Moving to a non-member state. If the compact privilege holder's new primary state of residence is a non-member state, all current compact privileges will be immediately terminated.

4) Rule 1.1 - Definitions

Reason: To add a new definition of "Initial".

Proposed Amendment:

"Initial" means each and every new Compact Privilege issued to an individual, even if a prior Compact Privilege was held in the same state.

5) Rule 3.8 - Jurisprudence

Reason: To clarify the jurisprudence requirements.

Proposed Amendment:

- (A) If a member state has a jurisprudence requirement to be eligible to obtain a compact privilege in accordance with Section 4.A.7. of the Compact, the member state may allow the jurisprudence requirement to be completed after the issuance of the compact privilege. In that situation, the deadline to complete the jurisprudence requirement is thirty (30) days.
- (B) A member state may choose to have a jurisprudence requirement in accordance with Section 4.A.7 of the Compact for initial purchase of a compact privilege, for renewal of a compact privilege, or for both initial purchase and renewal of a compact privilege. The member state may identify timeframe requirements for completion of the jurisprudence requirement.
- (C) If a privilege expires, and the individual purchases a new initial privilege in the same state, all applicable requirements for completion of a jurisprudence requirement prior to initial purchase apply.

6) Rule 3.1 - Home State License

Reason: To clarify the National Physical Therapy Examination (NPTE) as the requirement for licensure.

Proposed Amendment:

(E) An individual holding a home state license issued without the requirement of passing the National Physical Therapy Examination (NPTE) shall not be eligible for a Compact Privilege, unless said license was issued prior to the member state enacting the Physical Therapy Compact model statute.

Suggested Draft Policies and Procedures Amendment

1) Amend policy 3.2 to address reporting of adverse actions determined to be a significant threat to public protection.

POLICY NUMBER: 3.2 AREA: Discipline

AUTHORITY: PT Compact Rules - 6.3 and 6.4

PURPOSE: To establish the process by which member states will report adverse

actions to the Physical Therapy Compact Commission (PTCC).

DATE APPROVED: October 25, 2020; October 28, 2018

Policy:

Member states must report any new adverse actions taken on a license or compact privilege to the PTCC.

Procedure:

- 1. Member states will use the jurisdiction interface of the Federation of State Boards of Physical Therapy (FSBPT) Electronic Licensure and Disciplinary Database (ELDD) to log any disciplinary action taken on a license or compact privilege in accordance with the requirements of Rule 6.4.
- 2. The effective date of the adverse action as reference in Rule 6.4 is to be defined as the date in which the board order officially goes into effect subsequent to any appeals or mandated delays.
- 3. Member states are to report adverse actions as soon as possible and do not need to wait until the maximum number of days allowed in the requirements of Rule 6.4. Adverse actions determined by the member state to be related to a significant threat to public protection should be reported at the earliest possible date after the effective date of the action.
